ADDENDUM NUMBER 2 TO AGREEMENT BETWEEN THE NORWEGIAN AGENCY FOR DEVELOPMENT COOPERATION AND CENTAR ZA PROMOCIJU CIVILNOG DRUSTA (ENG. CENTRE FOR CIVIL SOCIETY PROMOTION) (CPCD) CONCERNING SMART BALKANS, RER-21/0005 REGIONAL PROGRAM FOR CIVIL SOCIETY IN THE WESTERN BALKANS

1 BACKGROUND

- 1.1 The Norwegian Agency for Development Cooperation (Norad), represented by the Section for Prevention and Stabilisation and CPCD (the Grant Recipient) (jointly referred to as the Parties) have entered into an agreement dated 21 November 2024 (the Agreement) as amended by addendum number 1 dated 5 June 2024 concerning RER-21/0005 Regional Program for Civil Society in the Western Balkans (the Project).
- 1.2 The Grant Recipient has submitted a request to Norad dated 20 November 2024 regarding additional financial support to the Project with which Norad has decided to comply.
- 1.3 The Parties have agreed to amend the Agreement through this addendum number 2 (the Addendum), which shall be an integrated part of the Agreement.

2 ADDITIONAL GRANT

- 2.1 Norad shall, subject to Norwegian parliamentary appropriations and on the terms and conditions of the Agreement, including previous addenda, and this Addendum, provide an additional grant not exceeding NOK 600 000 (Norwegian Kroner six-hundred-thousand (the Additional Grant)).
- 2.2 The Additional Grant shall be used exclusively to finance the Project as specified in the budget attached as Annex A to this Addendum, and in the Application during the Support Period.
- 2.3 The Additional Grant shall be disbursed upon signing of this Addendum.

3 CONDITIONS

The Additional Grant and its outputs shall be included in an updated budget to be submitted to Norad by 15 December 2024. Furthermore, the Additional Grant and its outputs shall be included in the financial reporting and the narrative reporting of the full SMART Balkans Project.

4 REMAINING CONDITIONS OF THE AGREEMENT

- 4.1 All other provisions of the Agreement shall remain unchanged and in force.

5 ENTRY INTO FORCE AND DURATION

- 5.1 The Addendum shall enter into force on the date of the last signature and remain in force until all obligations arising from it have been fulfilled.

This Addendum has been signed by both Parties. In the event of any discrepancies between this English language version and any later translations, the English language version shall prevail.
